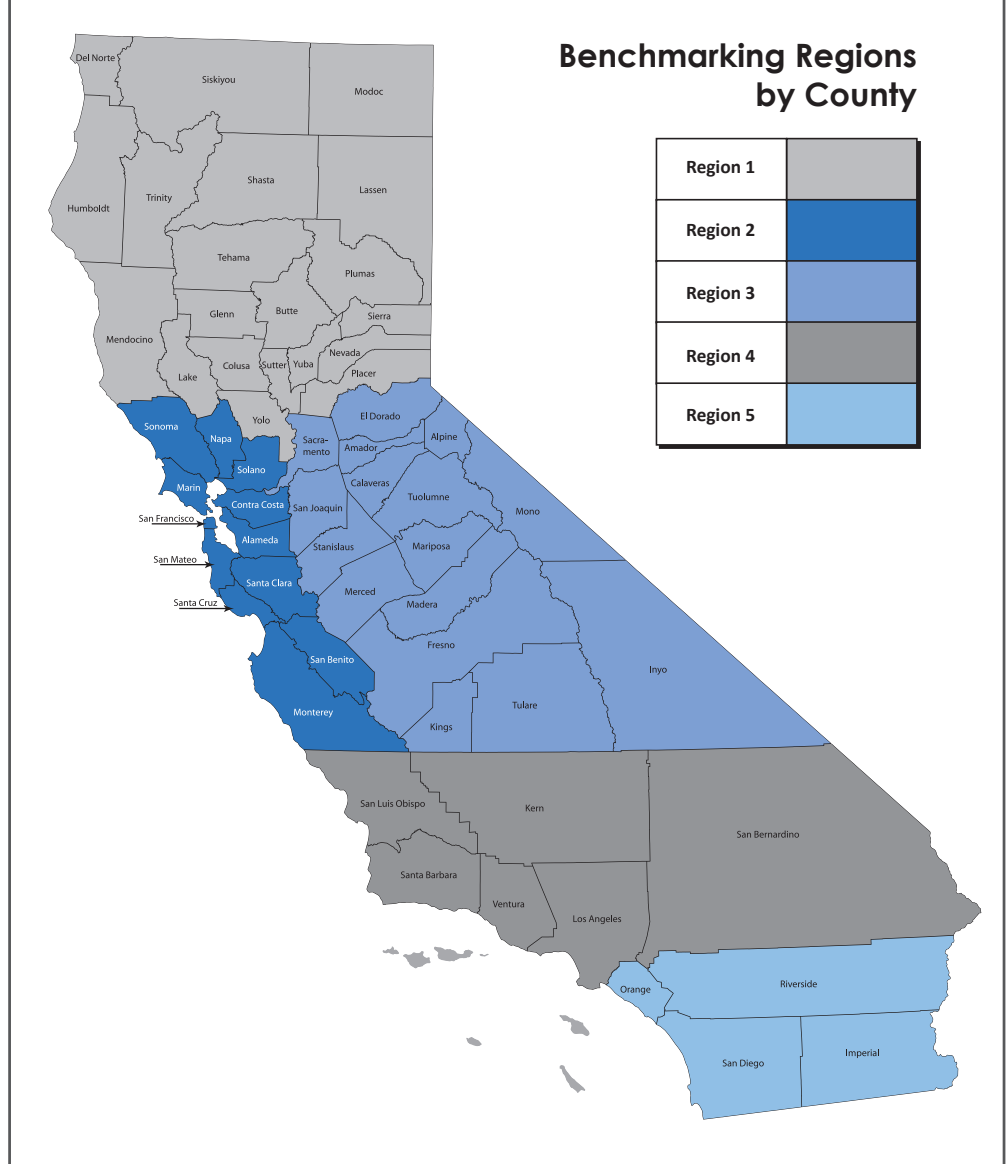

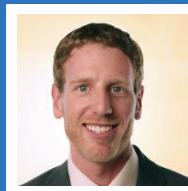
CASA is a constant resource when managing the overwhelming amount of
